
12-26-92 Spudded well at 5:00 pm. Drilled to 235'. Ran 5 jts. 9 5/8", 36.0#, K-55 surface casing set at 235'. Cemented with 300 sks. Class "B" with 2% calcium chloride and 1/4#/sx flocele (354 cu.ft.) circulated to surface. WOC 12 hrs. Tested 600#/30 min., ok.

12-29-92 TD 2241'. Ran 52 jts. 7", 20.0# K-55 casing, 2213' set @ 2225'. Cemented with 315 sks. Class "B" 65/35 with 6% gel, 2% calcium chloride and 1/4#/sx flocele (552 cu.ft.) followed by 100 sx Class "B" w/2% calcium chloride (118 cu.ft.). circ to surface. WOC 12 hours. Held 1200#/30 min.
