Bloomfield Refinery Class I Disposal Well (GW-130)

Dear Mr. Shelton:

On November 5, 1993, the groundwater discharge plan, GW-130, for the Giant Refining Company (Giant) Class I Disposal Well located in the SE/4 NE/4 of Section 27, Township 29 North, Range 11 West, NMPM, San Juan County, New Mexico, was approved by the Director of the New Mexico Oil Conservation Division (OCD). This discharge plan was required and submitted pursuant to Water Quality Control Commission (WQCC) regulation 3106 and was approved pursuant to section 3109 for a period of five years. The approval will expire on November 4, 1998.

If the facility continues to have potential or actual effluent or leachate discharges and Giant wishes to continue operations, the discharge plan must be renewed. The OCD is reviewing discharge plan submittals and renewals carefully and the review time can extend for several weeks to months. Please indicate whether Giant has made, or intends to make, any changes in the system, and if so, please include these modifications in the application for renewal.

The discharge plan renewal application for the Class I Disposal Well is subject to the WQCC Regulation 3114. Every billable facility submitting a discharge plan renewal will be assessed a fee equal to the filing fee of \$50 plus a flat fee of \$690 for Class I injection wells. The \$50 filing fee is to be submitted with the discharge plan renewal application and is nonrefundable. The flat fee for an approved discharge plan renewal may be paid in a single payment due at the time of approval, or in equal annual installments over the duration of the discharge plan with the first payment due at the time of approval.


