- 5-16-00 Spud 8 5/8" surface hole. Drill to 135'. Ran 3 jts 7" 17# casing and set at 135'. Cemented with 60 sxs Class "B" Neat cement with 1/4# celloflake and 3% CaCl2. Circulated 4 bbls cement to surface.
- 5-17-00 Test BOP and casing to 2000#
- 5-19-00 Drill to 1370' TD.
- 5-20-00 Run 31 jts 4 1/2" 10.5# casing to 1367'. Cemented with 75 sxs Class B cement w/ 2% metasilicate and 75 sxs Class B w/ 2% CaCl2. Circulated 9 bbls cement to surface. Plug down at 12:50 hrs.
