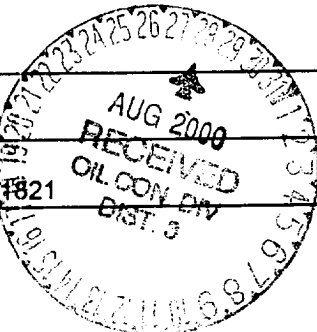

Drill to 1100' TD. Run 4-1/2" 10.5# casing. Landed @ 1090'. Cement with 124 cu ft 2% LoDense class "B" containing 1/4#/sx celloflake, tailed with 72 cu ft class "B" neat. Circulate 10 bbls cement to surface. Job complete 6/16/2000.
