- 6-07-01 Test BOP to 2000#. Test casing to 600PSI/30 min. TIH w/ 6 1/4" bit. Tag CM @ 108' Drill out CM. Continue to 600'
- 6-08-01 Drill to 950' KB-OHTD. Ran 23 jts 4 1/2" 10# casing RIH with 4 1/2" guide shoe @ 947.64'KB, flow collars @ 913'KB. Pump 45 sxs B 2% C Pump 105 sxs Class B 1/4" CELLO @ 1.18 yield. Pump 15 BBLS Water, RDSL.
