9-14-02 Spud 8 3/4" surface hole. Drill to 126'. Ran 3 jts. 7" K-55 20# casing; set at 126' KB. Cemented with 70 sx (83 cf) Class 'B' w/ 2 % CaCl, 1/4# celloflake. Circ. 5 Bbl cement to pit. WOC 36 hours.

9-16-02 Install and test BOP to 600 psi, 30 min; test good. Test surface casing to 600 psi, 30 min; test good. Drill 6 1/4" hole to 690'. SDFN

9-17-02 Drill 6 1/4" to 1200'; TD. Tally and run 32 joints 4.5" K-55 10.5# casing; set guide shoe at 1200.58' KB. Cemented with 52 sx (107 cf) Class 'B' with 2% metasilicate, 1/4# celloflake and 65 sx (77 cf) Class 'B' with 2 % CaCl. Bumped plug to 800 psi. Circ. 8 bbl cmt to surface.
