Tagged fill @ 7930'. Cleaned out fill from 7930' - 8030' PBD. Circ. hole clean. POOH. Kill well w/2% KCl. RIH w/2-3/8", tubing and set @ 7970' with "F" nipple set @ 7937'. ND BOP, NU WH. Pumped off expendable check. RD & released rig 6/13/01. Well returned to production as commingled on 6/15/01. Well will be commingled per DHC Order 432AZ.
