RIH & drilled 8-3/4" hole to 3700'. Ran pressure cores from 3264' to 3273' and 3276' to 3285'. RU Schlumberger and ran GR/DIL/ DN/ML/NGT & GR/Sonic logs. RU & RIH with 7" 23 lb/ft, J-55 casing and set @ 3698'. RU BJ Cementing Services & cemented with 600 sx 65:35 POZ, 12% Gel @ 12 ppg followed by a tail of 150 sx Class "B" cement. Circulated 459 sx to surface. WOC. NU BOP and pressure tested to 3000 psi - okay.

RIH & drilled 6-1/4" hole to 8050'. TOOH. RU Schlumberger and ran GR/DIL/DN/Temp/Caliper logs. RU and RIH with 196 jts. of 4-1/2", 11.6 lb/ft., N-80 LT&C casing and set @ 8042'. RU Western Cementing and cemented with 210 sx 65:35 POZ with 12% gel, 0.25 lb/sx Flocele, and 2% CaCl2 @ 12 ppg followed by tail of 150 sx Class "B" cement. Disp. plug with 12 bbls. Pressure tested 4-1/2" casing to 2000 psi-okay. Set slips with 91,000#. NU WH & tested to 3000 psi for 30 minutes-okay. RD & released rig @ 1315 hrs on 8-18-93. RU Jay Wireline. RIH with temperature survey. Top of cement @ 3220'. TOOH. Rd and released wireline.
