

LO/TO location. MIRU. Kill well/KCl. ND WH & NU BOP. COOH w/tubing. RIH w/bit & CO to PBTD. COOH. RIH w/CIBP & set @ 8180'. RIH w/Ret. packer & find casing leak. Squeeze leak. RIH & drill out cement. Test squeeze to 500 psi for 30 minutes. Drill out CIBP. COOH. RIH w/2-3/8" tubing and set @ +/- 8030'. Set BPV. ND BOP, NU WH. PT-OK. Pumped off expendable check. RD & release rig. Return well to production.
