RIH w/6-1/4" bit tagged cement @ 3780' & drilled ahead to 3800' PT 7" casing to 200 psi, and then 1500 psi - good test. Drilled shoe to 3835'. Drilled new formation to 8134' - TD. TD reached 10/10/00. Circ. hole. RIH w/4-1/2", 11.6#, I-80 casing and set @ 8134'.

RU to cement. Pumped 5 bbls KCL, 10 bbls gelled water, and 10 bbls KCL ahead of Lead cement - 270 sx (586 cf - 104.36 bbl slurry) Type III, 35/65 POZ, 6% Bentonite, 10#/sx CSE, 0.02#/sx Static Free, 1% FL-52, 0.3% CD-32, 0.3% R-3, 1/4#/sx Cello-flake. Tail - pumped 50 sx (63 cf - 11.21 bbl slurry) Class H, 1/4#/sx Cello-flake, 5#/sx Gilsonite, 0.3% FL-25. Displaced with 126 bbls H₂O. Plug down @ 1115 hrs 10/11/00. Float held. ND BOP, set slips and cut off casing. RD & released rig 10/11/00.

Will report TOC and casing pressure test on next report.
