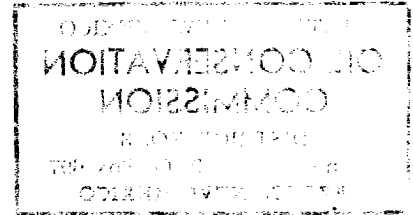

1. *Chlorophyll a* and *Chlorophyll b* were determined using a spectrophotometer (Shimadzu UV-160U) at wavelengths of 663 nm and 646 nm, respectively. The concentrations were calculated using the following equations:  $Chl\ a = 11.95 \times OD_{663} - 1.88 \times OD_{646}$  and  $Chl\ b = 21.08 \times OD_{646} - 6.30 \times OD_{663}$  (Morel and Wainman 1995).

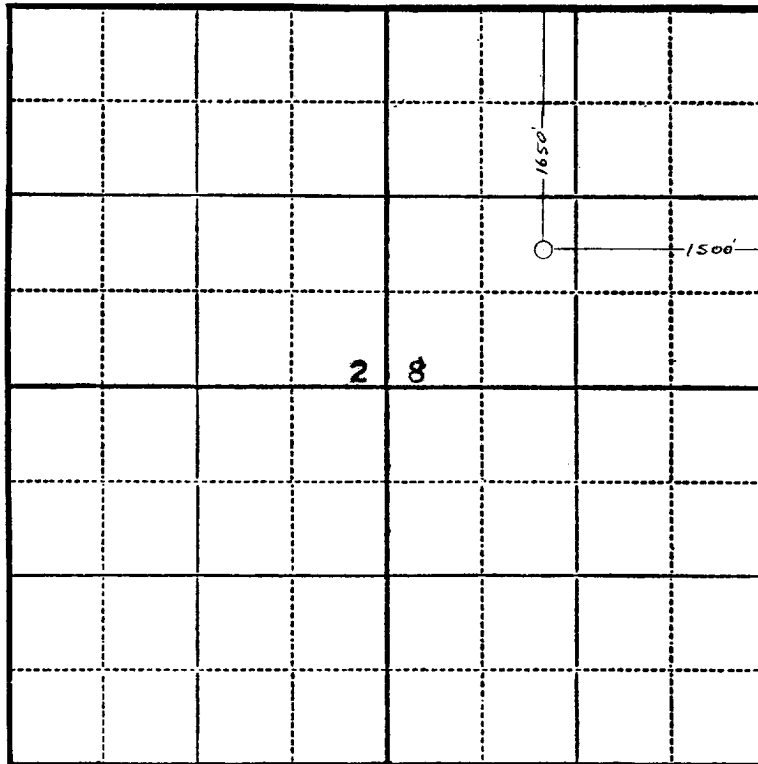
