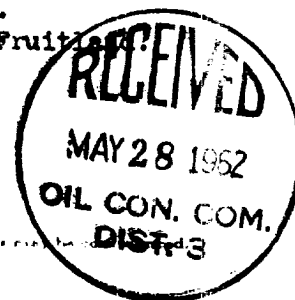
It is intended to mud drill a well with rotary tools thru the Pictured Cliffs formation and to perforate and fracture possible producing zones. Est. T. D. 2564'.

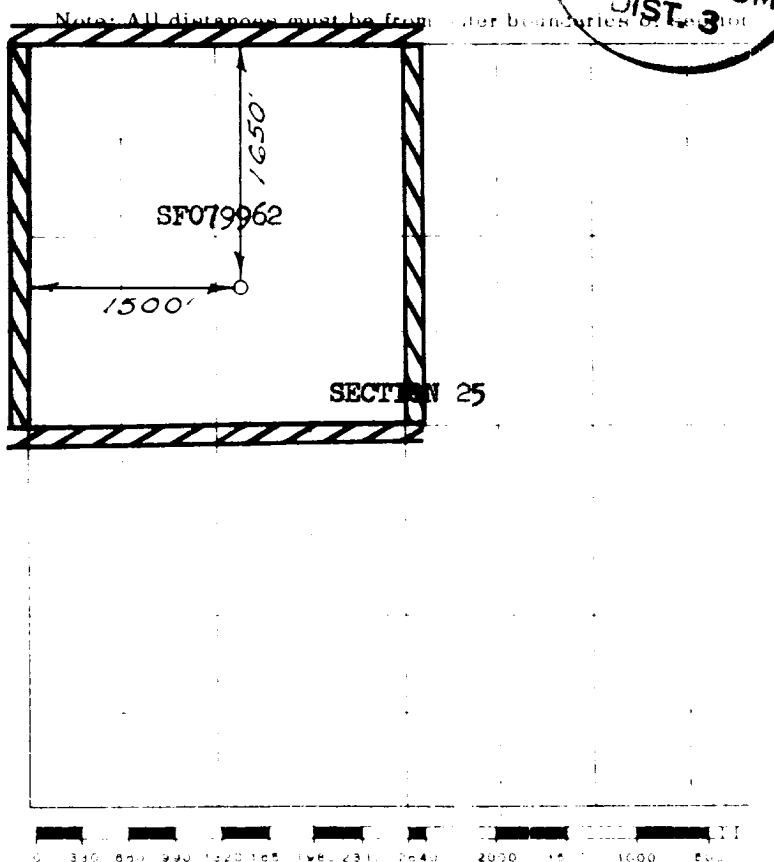
