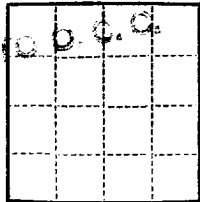

DETAILS OF WORK

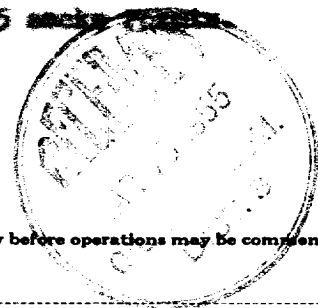

It is intended to drill a well thru the Pictured Cliff formation using rotary tools to the casing point and to drill the pay section with cable tools and to sand-oil fracture the entire pay section. Total depth 2320'.

Casing Program:

- 9 5/8" at 180' with 125 sacks regular cement circulated to surface.
- 5 1/2" at 2255' with 75 sacks regular cement, 75 sacks ~~fracturing~~

The NE 1/4 of section 27 is dedicated to this well.
