Gentlemen:

El Paso Natural Gas Company hereby submits its application for administrative approval of a non-standard proration unit comprising the West half (W/2) (or E/2 NW/4, E/2 SW/4, Lots 1,2,3,4) of Section 19, Township 30 North, Range 10 West, San Juan County, New Mexico, and in support thereof states the following facts:

1. The Ludwick #12 Well, located 990 feet from the South line and 1550 feet from the West line of Section 19, Township 30 North, Range 10 West, was completed as a gas well on October 3, 1956.
2. That the proposed non-standard gas proration unit consists of 311.60 acres which are contiguous quarter-quarter sections and lots.
3. That the proposed non-standard gas proration unit lies wholly within a single governmental section.
4. That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.
5. That a copy of this letter of application was not sent to any other operator inasmuch as El Paso Natural Gas Company owns all working interest (a) in the section in which any part of the non-standard proration unit is situated and which acreage is not included in said non-standard gas proration unit, and (b) in acreage offsetting the non-standard proration unit.



Therefore, El Paso Natural Gas Company requests that under the provisions of Rule 1 (b) of Order No. R-128-C, the Secretary of the Commission grant exception to Rule 1 (a) without Notice and Hearing, and approve the subject non-standard gas proration unit.

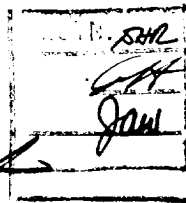

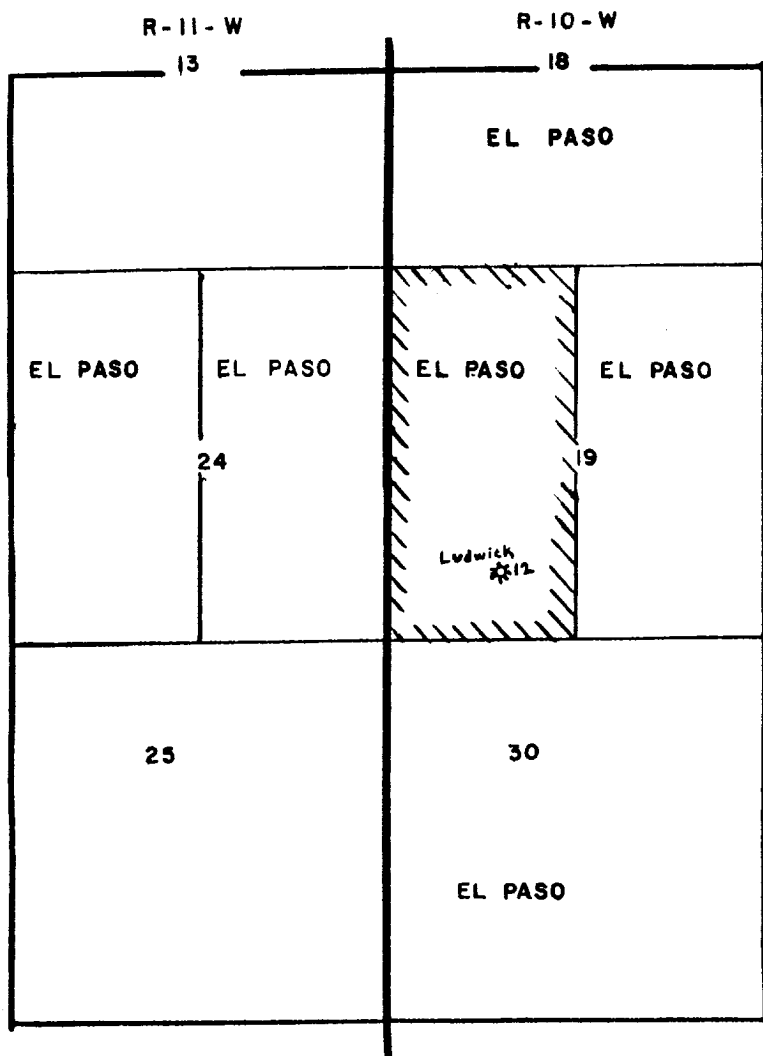
