Well No. 1 is located 990 ft. from N line and 990 ft. from W line of sec. 20NW Section 20 (1/4 Sec. and Sec. No.) 30N (Twp.) 10W (Range) N. M. P. M. (Meridian)Astec Pool (Field) San Juan (County or Subdivision) New Mexico (State or Territory)The elevation of the derrick floor above sea level is 6306 ft.

## DETAILS OF WORK

It is intended to drill a well with rotary tools to the top of the Pictured Cliffs formation, completing the well with cable tools, and to shoot the pay section with two quarts S.N.G. per foot. Total depth 2875'.

Casing program:

3-5/8" at 100' with 75 sacks regular cement circulated to surface.

5-1/2" at 2800' with 150 sacks regular cement.

The NW 1/4 of Section 20 is dedicated to this well.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
