Enclosed is a letter written us by Mr. Linn Blancett of Aztec about a gas well drilled on his property by Mr. John G. Polokoff. The well is located in the SE $\frac{1}{4}$  Section 13-30N-12W in the Aztec Pictured Cliffs Pool.

When Mr. Polokoff completed this well he had water trouble and was unable to determine whether the water was coming from casing leaks or from the Pictured Cliffs formation. At any rate, after a very short period of production the well seems to be logged off with water, and as Mr. Blancett points out in his letter, has produced very little gas and in the last several months has produced none at all.

I believe, therefore, that his request that we force plugging on this well is justified and I recommend that we advertise the case for hearing in February.
