DETAILS OF WORK

It is intended to drill and dual complete a well in the Pictured Cliffs formation & Mesa Verde formation. Mud circulation will be used thru the Pictured Cliffs formation and set intermediate casing. Gas circulation will be used thru the Mesa Verde & a production liner will be set. Possible productive intervals will be perforated and fractured. Estimated Total Depth 5174'.

10 3/4" at 170 with 150 sacks cement circulated to the surface.

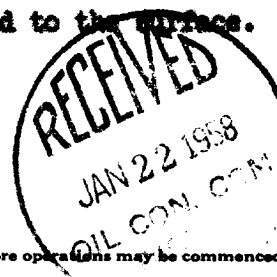
7 5/8" at 4834' with 250 sacks cement.

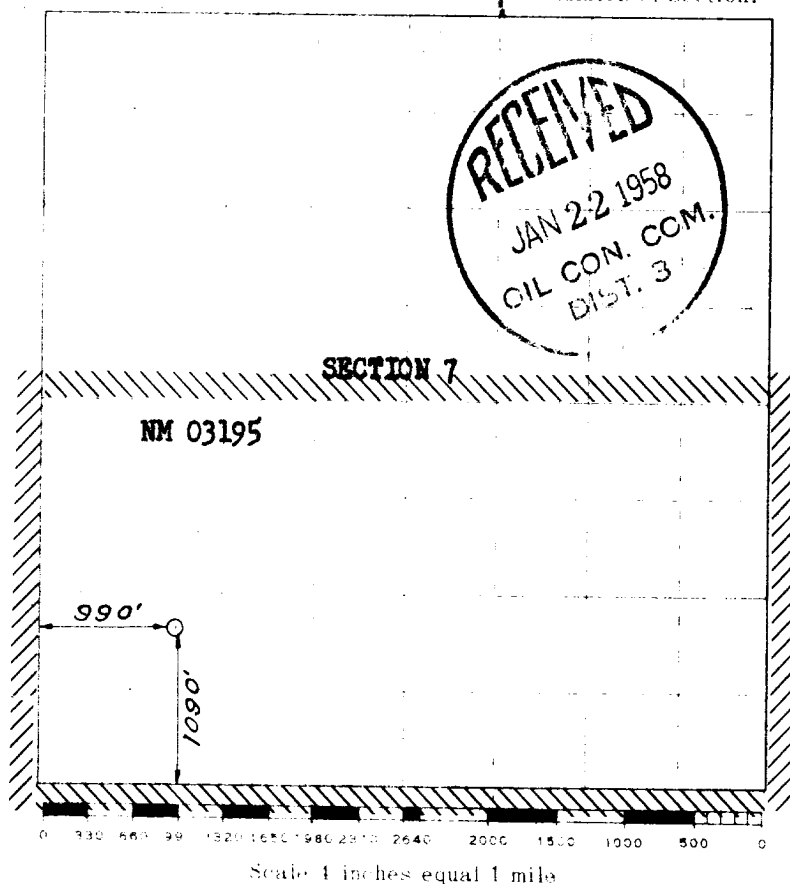
