Dear Dick:

Enclosed are copies of letters which have been written regarding the Owen Drilling Company #1 Jones, (formerly the #1 Shepard) in the SE/4, Sec. 7-30N-11W. I am bringing this to your attention because the interested parties have seemed from the beginning to be a little confused about our rules and regulations and have also been a little confused even concerning their own operations.

For your information I will attempt to briefly review the history of this operation: Early in November Mr. Juan Moya came into the office with a Notice of Intention to Drill on this 160 acres, designating himself as operator, saying that he was going to get an assignment to this acreage. We informed him that we could not accept his Notice of Intention to Drill, as he did not have a plugging bond, and also, to our knowledge, did not have an assignment to the acreage. He then contacted the Owen Drilling Company and filed a Noticea of Intention to Drill designating the Owen Drilling Company as operator, which we approved. At the present time it seems that Mr. Owen wishes to transfer ownership of the well to Mr. Moya and as you will note from the enclosures I have written to Mr. Owen, with a copy to Mr. Moya, explaining to them how this must be done.

If there is any future correspondence regarding this well, we will send you all copies.
