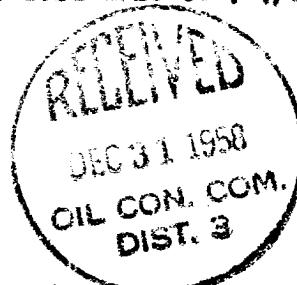

DETAILS OF WORK

O. J. Hoover "B" Well No. 5 - Was spudded on December 21, 1958, and on December 22, 1958, 8 5/8" casing was set at 215' with 160 sacks of cement. After waiting on cement casing and water shut off were tested with 400 pounds pressure for 30 minutes which held with no drop in pressure. Reduced hole to 7 7/8" at 216' and resumed drilling operations.
