ARCO Oil and Gas Company respectfully requests approval for extension of long term shut-in status on this well. ARCO continues to find ways to reactivate previously uneconomic long term shut-in wells and has returned several to production as market conditions and production allowed. As you are aware, ARCO is selling it's working interest in the Horseshoe Gallup Unit and the new owners are very interested in reactivating long term shut-in wells especially with the recent increase in oil prices. For these reasons, ARCO proposes that this well be maintained in the long term shut-in status so that the wellbore will be available, should future production tests indicate commercial production. This plan eliminates the economic waste of potentially usable wellbores and allows for their conservation.
