
It is intended to drill a well with rotary tools in the following manner:

1. To drill through the Mesaverde to total depth 5280'.
2. To drill the pay section with gas circulation.
3. To shoot the entire Mesaverde with approximately two quarts S.N.G. per foot.

Casing Program:

9-5/8" at 150' with cement to surface.
7 " at 4400' with 300 sacks regular cement.

E 1/2 of Section 4 is dedicated to this well.
I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
