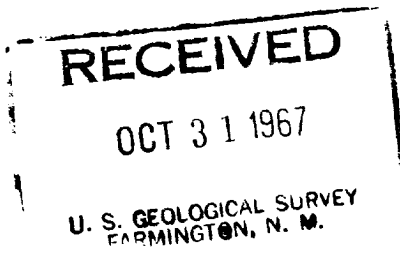

Set 20 sack plug regular cement from 800' to 600' in 4.75" hole. Ran 2 7/8" casing to 382' and cemented from 382' to surface with 60 sacks of regular cement. Perforated and acidized Gallup formation with 200 gal. Mud acid from 295' to 301'-6' and from 306.5' to 310'-3.5'. Work commenced on 10-19-67 and completed on 10-22-67. Presently testing well.
