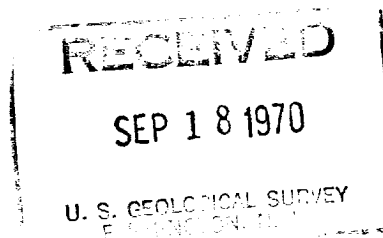
On 8-18-70 spudded well, drilled surface hole.

On 8-31-70 T.D. 2729', ran 89 joints 2 7/8", JE, production casing (2718') set at 2729' w/250 sacks of cement. W.O.C. until completion.

On 9-9-70 P.B. T.D. 2718', perf. 2586-2602', 2612-20' w/32 SPZ.

Frac w/30,000# 10/20 sand, 30,072 gal. water, dropped 1 set of 32 balls, flushed w/630 gal. water.

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
