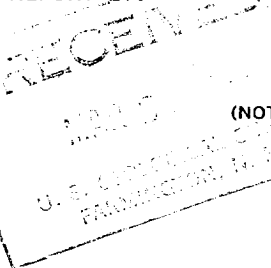

3/20/81 Ran 137 joints (4489.13') of 4-1/2", 11.6# & 10.5#, K-55 casing set from 2809' to 7298'. Cemented with 710 sacks of Class "B" 50/50 Poz with 6% gel, 1/4# flocele per sack, .6% Halad 9 and .5% CFR-2. Plug down at 1:15 P.M. 3-20-81.
