Spudded 8 3/4" hole 07/03/85. Drilled to 67'. Ran 2 jts. 7" 23lb./ft. J-55 casing and set at 67'. Cemented with 41 cu. ft. class "B" cement with 1/4 lb. Flocele/SK and 3% CaCl2. (yield 1.18 cu. ft/sk) plug down 1630 hrs. 07/09/85. Circulated 5 cu. ft. slurry to surface. Pressure test casing to 250 psi prior to drilling out.
