Re-cavitation operations commenced on 3-14-02 and ended on 4-3-02. Pressure tested 7" casing before operations began. The 5-1/2" uncemented liner was installed and performed with 4 SPF from 3260' to 3545' with a total of 196 shots. Top of liner hanger at 3151' KB. Bottom of liner bit shoe at 3547' KB. 2-3/8" tubing set at 3537' KB.
