Recavitation operations commenced on 6-18-02 and ended on 7-24-02. Pressure tested 7" casing before operations began. The 5-1/2" uncemented liner was installed and performed with 4 SPF from 3110' to 3290' with a total of 392 shots. Top of liner at 2938' KB. Bottom of liner bit shoe at 3298' KB. 2-3/8" tubing set at 3277' KB.
