Class "B" 65/35 Pozmix, 6% gel, 5 pps gilsonite, 1/4 pps flocele and 2% calcium chloride, (422 cu.ft.) tailed by 100 sks. Class "B" w/2% calcium chloride (118 cu.ft.). Cemented 2nd stage with 585 sks. Class "B" 65/35 Pozmix, 6% gel, 5 pps gilsonite, 1/4 pps flocele and 2% calcium chloride (1035 cu.ft.), tailed w/100 sx Class "B" w/2% calcium chloride (118 cu.ft.). Circulated 5 bbl to surface. WOC 18 hours.
