10-19-00 TOOH. TIH w/80 jts 7" 20# J-55 ST&C csg, set @ 3341'. Cmdt w/346 sx Class "G" neat cmt w/3% D-79, 2% calcium chloride, 0.25 pps cellophane, 10 pps gilsonite, 1% defoamer (1021 cu ft). Tail w/91 sx class "G" 50/50 poz w/2% gel, 2% calcium chloride, 0.25 pps cellophane, 5 pps gilsonite (116 cu ft). Circ 83 bbl cmt to surface. PT BOP & csg to 1500 psi/30 min, OK. Drilling ahead.

10-22-00 Drill to TD @ 7680'. Circ hole clean.
