Pumped a preflush of 10 bbls mud clean, 10 bbls FW w/red dye ahead of 415 sx (586 cf - 175.6 bbl slurry) Type 3 cement 35/65 POZ w/5#/sx LCM-1, 1/4#/sx Cello-flake, 6% gel, 10#/sx CSE, 3% KCL, 0.4% FL-25, 0.02#/sx Static Free.

Pumped tail - 50 sx (70 cf - 12.5 bbls slurry) Type 3 cement w/1/4#/sx Cello-flake, 1% CaCl2. Dropped plug & displaced w/122.3 bbls FW. Plug down @ 0203 hrs 4/10/01. Circ. 30 bbls cement to surface. WOC.

ND BOP, set slips and cut off casing. NU BOP, choke & lines. PT rams, valves, and casing to 200# 3 minutes and 3000# 10 minutes. Good test.
