Cross Timbers Operating Co. (now known as XTO Energy) spudded the above mentioned well on 7/25/01 @ 4:00 p.m.

Cross Timbers set 12 jts of 7", 20#, J-55 surface casing @ 209' KB. The surface casing was cemented with 78 sx cement. 10 bbls of good cement was circulated to surface. The BOP's and surface casing were pressure tested to 800 psig for 30 min. Everything held OK. Drilling resumed.
