Pumped a preflush of 10 bbls mud clean and 10 bbls dye water ahead of 220 sx (310 cf - 55.20 bbl slurry) Type 3, 2% CaCl2, 0.25#/sx Cello-flake. Displaced w/25 bbls water. Plug down @ 0556 hrs 7/12/02. Circ. 10 bbls cement to surface. WOC. PT rams, manifold and casing to 250 psi low and 1800 psi high. Good test.
