Drill 12-1/4" hole to 283'. On 8/18/02 ran 6 jts. 9-5/8" ST&C, H-40, 32.3# casing; set at 275'. Cement with 200 sacks (42 bbls) class "B" cement, yield 2% CaCl, 1/4# PSX Floseal yld. 1.18. Circulate 22 bbls cement to surface. **Pressure test casing to 1500 psi.**

Drill 8-3/4" hole to 3561'. On 8/22/01 ran 7", 23#, J-55, LT&C casing. Set at 3561'.

Lead: Cement with 425 sacks (109.8 bbls) 50/50 POZ, 2% gel, 2% versaset and .1% diacel foamed cement.

Tail in with 75 sacks (19.4 bbls) 50/50 POZ, 2% gel, 2% versaset and .1% diacel non foamed cement. Circulate 30 bbls cement to pit.

Pressure test casing to 1500 psi.

Drill 6-1/4" hole to 7978', lost fish, side track @7382'. Drill 6-1/4" hole to 8035'. On 8/16/02 ran 4-1/2", 11.6#, LT&C casing. Set at 8130'.

Cement Lead: 400 sacks (103 bbls) 50/50 POZ with 2% gel, .15% versaset, 1% diacel LWL, .13 gal. P/SX foamer. Foamed w/N2.

Tail in with 230 sacks (60 bbls) 50/50 POZ with 2% gl, .15% versaset, 1% diacel LWL, yield 1.44. Circulate 10 bbls foamed cement to surface.

Pressure test casing to 4300 psi.
