Set 150' of 10-3/4" OD surface pipe and circulate cement to surface. Set approximately 5,085' of 7" OD casing on top of Mesa Verde formation and cement with 200 to 350 sacks of cement.

Gas drill to approximately 6035' or through the Point Lookout section of Mesa Verde Formation.

Shot pay zone with two quarts of Nitro per foot. Gas drill to clean out after shot to complete.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

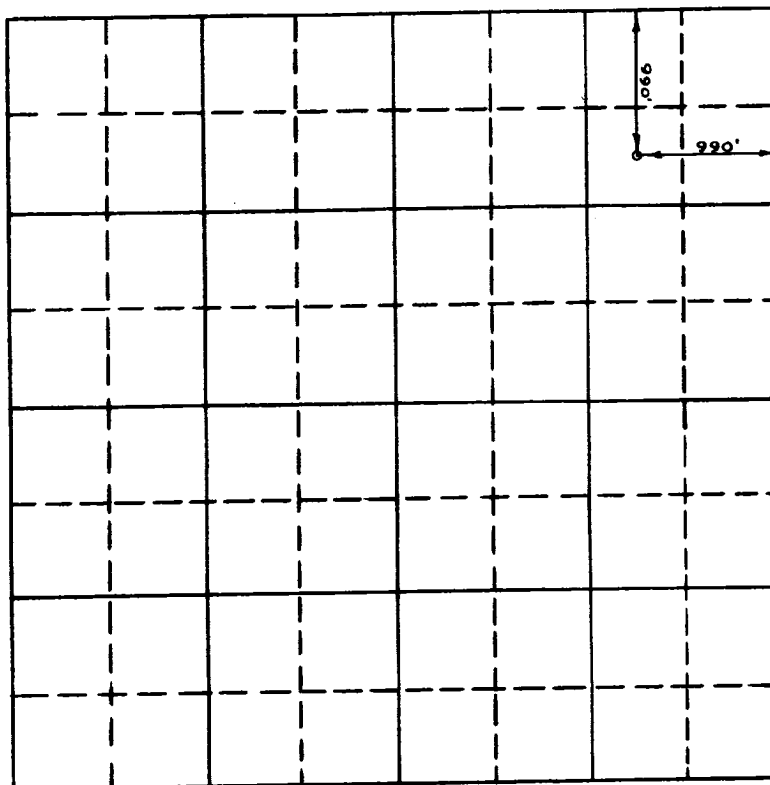

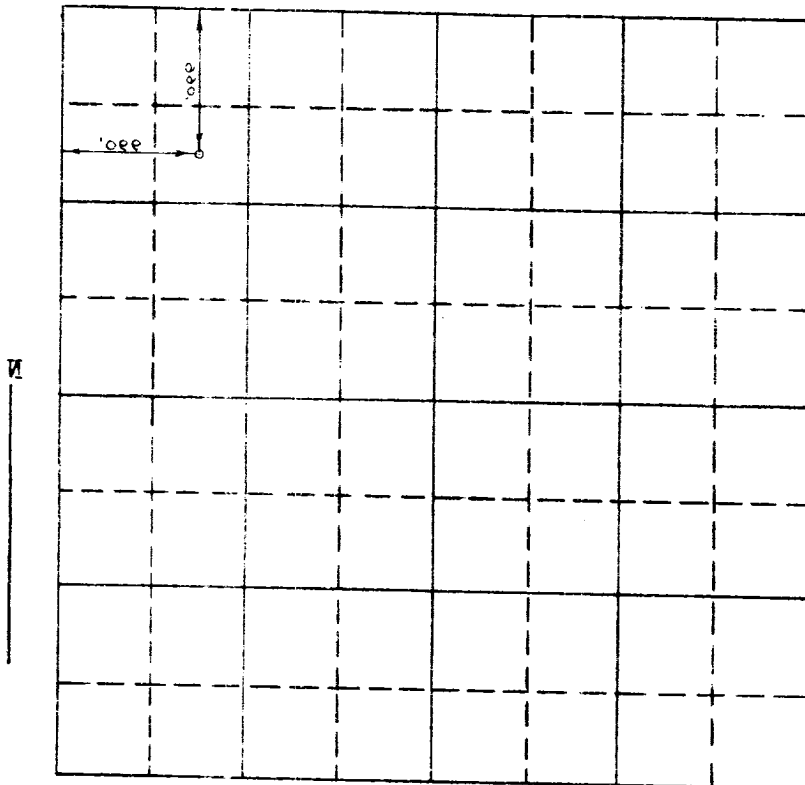
