DETAILS OF WORK

Well was drilled to a total depth of 1200' and 13-1/8" casing was landed at that depth. Casing cemented with 450 sacks Quikstrength cement containing 45 gal and 1-1/2" Tuf Plug per sack followed by 100 sacks Quikstrength mud. After waiting on cement tested casing to 1000 psi for 30 minutes. Test O.K. Reduced hole to 12-1/4" and resumed drilling.

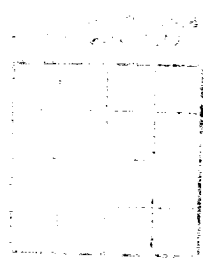
