We intend to abandon the Dakota Formation on this well by performing the following: Go in hole with TBG and bit to 6318' and drill out Howco Bridge plug. Proceed to tight spot in CSG @ 6369'. Proceed to 7250' and come out of hole. Go back in hole with TGB and cement retainer and set retainer at 7250'. Cement from bottom perf @ 8106' to 7250' (856') with (44.28 sks. class 'B' cement with 6% gel) Pull TBG out of retainer and pump (2.59 sks. cement) (50' over retainer) pump 5.65 BBLS of 9#/6L mud from 7200' to 6835'. Set TBG @ 6835' and pump a 150' cement plug across Gallup using (7.76 sks. class 'B' with 6% gel). Proceed out of hole with TBG and pump 18.52 BBLS 9#/6L mud from 6685' to 5490'. Set TBG @ 5490' and pump a 150' cement plug across Mesa Verde zone using (7.76 sks. class 'B' with 6% gel). Pull TBG from well. We intend to perform this work in October of 1992, weather permitting. It is our eventual intention to complete in the PC formation when gas prices permit.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
