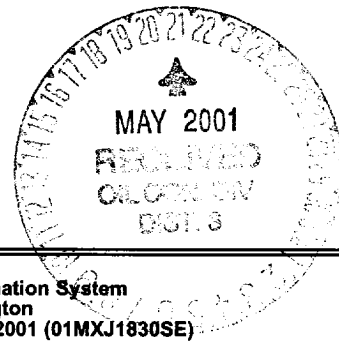

The subject well was restored to production in September 2000, however, by December 2000 will had ceased to produce. Will try to activate production - swab well or kick off with nitrogen, install artificial lift (plunger or rod pump) and/or add additional surface facilities for water storage. We anticipate completion by the end of the 3rd Qtr or beginning of the 4th Qtr of this year.
