Vastar elected to reperforate and refrac the Fruitland Coal in the subject well in an attempt to increase gas flow rates. Treated Fruitland perms 4094-4122 (28'), w/ 4 spf total 112 holes w/ 0.42" diameter w/ 500 gal 10% formic acid followed w/ 81,382 gal 25# Delta frac 140 gel w/ sandwedge containing 1,840 sx 20/40 Brady sand. After cleaning out the 5 1/2" csg to 4210' (PBTD) a 1.9", 2.76#, J-55, 10RD IJ 10RD tbg assembly was run w/ 2 GLM'S, 'F' nipple and WL Re-entry guide. No pkr, EOT at 4094'. Flow and clean well to flowback tank. Operator will return the well to production after hooking up surface facilities. Operations started on 06/30/2000 and were completed on 07/31/2000.
