

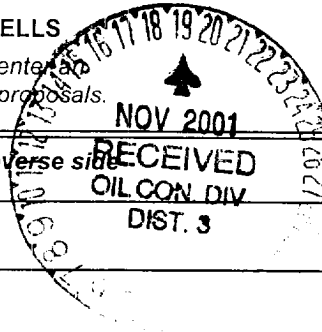

1. MIRU. TOH w/ Rods. TOH with tubing. TIH with fishing tools and jar 5 1/2" liner out of hole.
2. Pick up 6 1/4" Bit and Drill Pipe. Clean out to 3089'.
3. Cavatate well. Rerun liner.
4. Rerun tubing. Return to production.
