TOH and lay down 4 jts 5 1/2" casing. TIH and clean out to 3090'. Under ream open hole to 9 1/2" from 3000'-3090'. Cavitate well. Stuck drill pipe. Backed off at 2897', left 6 1/4" bit, 4 drill collars and 2 jts drill pipe in hole. Set CIBP at 2870'. Set whipstock on top of CIBP at 2870'. TIH with mill and mill window in 7" casing from 2851'-2867'. Drill new hole to 3106'. Under ream open hole to 9" from 2880'-3106'. Cavitate well. TIH with 7 jts 5 1/2" 15.5# J-55 casing, set liner at 3105', TOL at 2794'. Predrilled perforations from 3019'-3044', 3048'-3062' and 3088'-3102'. TIH with 2 3/8" tubing, land at 3069'. ND BOP, NU wellhead. RDMO.
