Vastar elected to reperforate and refrac the Fruitland Coal in the subject well in an attempt to increase gas flow rates. Perforated Fruitland Coal fm 4028-4045 (17') Total 17' w/ 4 spf adding 68 holes w/ 0.42" diameter and treated all perfs w/ 500 gal 10 % formic acid followed w/ 54,492 gal 25# Delta frac 140 gel w/ sandwedge containing 1,240 sx 20/40 Brady sand. After cleaning out the 5 1/2" csg to 4163' (PBDT), a 1.9", 2.76#, J-55, 10RD IJ tbg assembly was run w/ 3 GLM'S, 'F' nipple and WL re-entry guide. No pkr, EOT at 4031'. Flow and clean well to a flowback tank. Operator will return the well to production after hooking up surface facilities. Operations started on 07/28/2000 and were completed on 08/23/2000.
