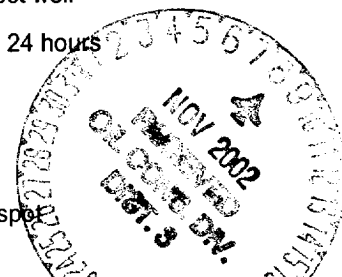

Notify regulatory agencies (BLM @ 505-599-8907) & (NMOCD Charlie Perrin 505-334-6178x16) 24 hours in advance of plugging activity. Use Class 8 #0218, B #0217; neat cement for all cement plugs.

1. Check anchors. MIRU workover rig.
2. Check & record tubing, casing, & bradenhead pressures.
3. Blow down wellhead. If necessary, kill with 2% KCL water.
4. Nipple down WH. NU BOPs. Pressure test BOPs to 500 psi.
5. TOH w/2-3/8" TBG. If TBG is in poor condition, LD production TBG & PU 2-3/8" workstring to spot CMT plugs. Note: CIBP is currently set @ 1856' kb (1842' md)
6. Spot 400' CMT plug (55 cu ft) from 1456' & #0218; 1856' above CIBP.
