James L. Nondorf, being first duly sworn according to law, upon his oath deposes and says:

1. That he is President of DEKA Exploration, Inc.
(Title) (Operator)
whose address is P.O. Box 14057, Oklahoma City, OK 73113.
2. That DEKA Exploration, Inc. is the operator of a well drilled on land belonging to Wayne E. Quinlan, whose address is P.O. Box 27
(Landowner)
St. Antonito, CO 81112, said well being drilled to test for hydrocarbons and/or carbon dioxide gas and described as the Quinlan Ranch No. 02-1, being located 170 feet from the North line and 340 feet from the East line of Section 23, Township 32 N, Range 2 E, NMPM, Rio Arriba County, New Mexico.
3. That said well was drilled to a total depth of 2450 feet, and that casing has been set and cemented as follows: Plugged back; TD 2212'; set 10 3/4" conductor to 30', cemented to surface; set 8 5/8" casing to 120', cemented w/85 sks; ran 5 1/2" casing to 1938' and cemented with 195 sks Lite, 90 CLS, 18 sks Standard. No casing was pulled.
4. That operator and landowner have made an agreement whereby operator (is) (~~is not~~) to back fill pits, level location, and clear it of all junk. The agreement further provides that operator is to plug said well back to a plugged-back total depth of 2212' feet and transfer well to landowner for his use as a water-well. Operator will leave casing in the well as follows:

5. That when operator has complied with the provisions of Paragraph 4 above it will so notify the Oil Conservation Commission of the State of New Mexico on Commission Form C-103, together with a signed statement from the landowner that the provisions of Paragraph 4 above have been complied with to his satisfaction.
