5-31-95 MOL and RU. Spud surface hole at 0145 hrs 5-31-95 with spud mud and bit #1 (12-1/4", HTC, OSC RR).

6-01-95 TD'd surface hole at 297'. TOH. Ran 6 jts. (277.06') of 9-5/8", 36#, K-55, ST&C casing and landed at 289' KB. Cemented with 150 sx. (177 cu.ft.) of CI "B" with 3% CaCl2 and 1/4# celloflake/sk. Displaced plug with 20 bbls of water. Plug down at 1015 hrs. 5/31/95. Circulated out 10 bbls cement to surface. Pressure test to 1500#- held O.K.

6-04-95 TD'd intermediate hole at 3530' with bit #2 (8-3/4", HTC, OSC).

6-05-95 Ran 82 jts (3541.00') of 7", 20#, K-55, ST&C casing and landed at 3530' KB. Float at 3486'. BJ cemented with 410 sx (841 cu.ft.) of CI "B" 65/35 poz with 2% CaCl2, 8% gel, and 1/4# cello-flake/sk. Tailed with 210 sx (248 cu.ft.) of CI "B" with 2% CaCl2 and 1/4# cello-flake/sk. Preceded cement with 20 bbls of gel water. Displaced cement with 143 bbls of water and plug down at 1115 hrs 6/4/95. Circulate 35 bbls of cement to surface. Pressure test BOP and casing to 1500# -held OK. Unload hole with nitrogen, dry hole. Well dusting at 0015 hrs 6/5/95.

6-07-95 TD'd well with bit #3 (6-1/4", HTC, J-33).

6-08-95 SWS ran IES/GR, CDL/CNL & TEMP logs. Ran 59 jts (2560.23') of 4-1/2", 10.5#, K-55, ST&C casing landed at 5909' KB. Float collar at 5884'. Top of marker jnt at 5244'. Top of liner hanger at 3345'. BJ cemented with 245 sx (424 cu.ft.) of CL "B" with 4% gel, 6-1/4# gilsonite/sk, and CF14(fluid loss). Displaced cement with 65 bbls of water and plug down at 1745 hrs 6/7/95. Reversed out 17 bbls of cement. Rig released at 2200 hrs 6/7/95.
