7/18/98 Ran 5 jts. 9 5/8", 36#, J-55, ST&C casing 222' set at 237'. Cemented with 150 sks. Class B w/ 2% CACL2 and 1/4# Flocele (177 Cu. FT.). Circ. 15 bls to surface. Plug down 2 a.m. 7/19/98. WOC 12 hrs. Tested casing to 600 PSI - Ok.

7/23/98 Ran 78 jts. 7", 20#, K-55, ST&C casing 3422; set at 3435'. Cemented with 590 sks. 65/35 Poz with 6% gel, 2% CACL2, 1/2#/sk flocele and 10#/sk gilsonite followed by 125 sks 50/50 Poz with 2% gel 1/2#/sk flocele and 10#/sk gilsonite and 2% CACL2 (1318 cu. ft.). Circ. 35 bbl to surface. Plug down 11 a.m. 7/23/98. WOC 12 hrs. Tested casing to 1200 psi - Ok.
