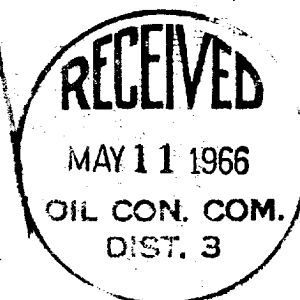
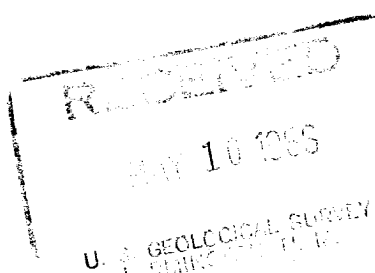

Max. 4000#, BHP 3600#, tr. pr. 2000-2600-4000#. Dropped 1 set of 60 balls and 3 sets of 30 balls each. Flush w/3460 gallons. ISIP vacuum. I.R. 32 BPM.

On 5-9-66 Cleaned out to 5690', set GO magnesium bridge plug at 5475', loaded hole w/treated water, tested w/4000#, perforated 5458-68', 5403-13' w/2 SDJ/ft., 5372-92' w/1 SDJ/ft., 4882-4900' w/20 holes, fraced w/33,000# 20/40 sand, 29,420 gallons water w/2 1/2# FR-8/1000 gallons. Max. pr. 4000#, BHP vacuum, tr. pr. 2200-2500-4400#. Dropped 2 sets of 20 balls each, balled off on second drop, would not release. I.R. 48 BPM.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
