DETAILS OF WORK

Drilled to a total depth of 1305'. Ran Schlumberger SP Sonic Log, their T.D. 1305'. Ran 40 joints 5-1/2" O.D. 14# H-40 casing = 1283.34'. Set at 1290.34' and cemented with 130 sacks regular mix Pozmix. Plug down at 1:35 P.M., 12-20-58. Ran 4 Baker centralizers. W.O.C. to 9:00 A.M., 12-21-58. Tested casing with 1200' for 30 minutes, O.K.
