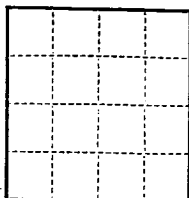

This well was spudded 4:00 P.M., 12-21-58. Drilled 12-1/4" hole to 101'. Ran 3 joints 8-5/8" O.D. 21# J-55 casing = 91.45'. Set at 100.03' and cemented with 80 sacks common cement plus 3% CaCl. Job complete 11:00 P.M., 12-21-58. W.O.C. 12 hours. Released pressure and nipped up BOP's. Found plug at 81'. Tested casing with 550" for 30 minutes, O.K. Started drilling plug 4:00 P.M., 12-22-58.
