This injection well was shut in October 1972 for further evaluation of production in the "D" area of the Unit resulting from this injection. U.S.G.S. approval of this shut in was 6-25-70, however, shut in of the well was deferred since small portions of the "D" area were being evaluated to note results that might be applicable to all of the "D" area.

This well is in a large Unit which is now under waterflood operations. Future plans are to conduct waterflood and tertiary recovery studies. These studies may result in a revised waterflood plan or in a tertiary recovery program that may require the use of this well in order to recover the maximum amount of oil from this reservoir.
