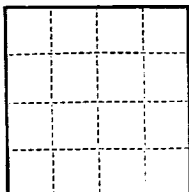

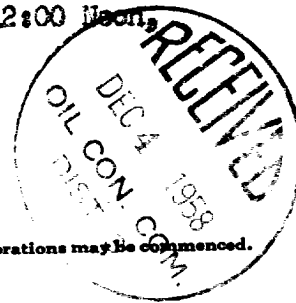

DETAILS OF WORK

This well was spudded 3:00 P.M., 11-25-58. Drilled to 102' SL1. Ran 3 joints 8-5/8" O.D. 2 1/2" J-55 casing = 90.96'. Set at 99.56 and cemented with 125 sacks common cement plus 3% CaCl. Plug down 8:00 P.M., 11-25-58. Cement circulated. W.O.C. to 8:00 A.M., 11-26-58. Released pressure, nipped up BOP's. Tested casing with 600# for 30 minutes, O.K. Started drilling plug 12:00 Noon, 11-26-58.
